

The Post Second World War International Order

- The United Nations
- The World Bank
- The International Monetary Fund
- The General Agreement on Trade Tariffs [1947 23 Members]
 - o 1947 Geneva Round (7 months) 45,000 tariff concessions
 - o 1949 Annecy Round (5 months) 5,000 tariff concessions (34 Members)
 - 1950 Torquay Round (34 months) 8700 tariff concessions and reduction of 1948 tariffs by 25%
 - o 1956 Geneva Round (5 months) \$2.5 Billion in tariff reductions
 - 1960 Dillon Round (11 months) \$4.9 Billion tariff reductions (45 members)
 - 1964 Kennedy Round (37 months) Anti-dumping rules, \$40 Billion tariff reductions
 - 1973 Tokyo Round (74 months) Tariff reductions of \$300 Billion (102 Members)
 [1974 Multifiber Agreement]
 - 1986 Uruguay Round (87 months) leading to formation of WTO in 1995.
 - o All of these were replaced by the Agreements at or following creation of the WTO




World Trade Organisation

- Established 1995, Final Act signed on 15 April 1994, in Marrakesh (thus called the Marrakesh Agreement) (164 Members, including the EU in its own right, and 25 Observer Governments) (Hong Kong joined GATT in 1987 and became member in 1995, later in 1997, as 'Hong Kong, China', PRC joined in 2001 and Taiwan joined in 2002 as Separate Custom Territory of Taiwan, Penghu, Kinmen and Matsu)
- WTO Agreement. Five principles:
 - Non-discrimination
 - Reciprocity
 - Binding and Enforceable Commitments
 - Transparency
 - Safety. Trade may be restricted for genuine public policy reasons –
 environmental protection and public health, and unfair competition.


World Trade Organisation

- Multilateral Agreement on Trade in Goods
- General Agreement on Trade in Services
- Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS)
- Various Protocols for Trade-Related Aspects of Investment Measures (TRIMS),
 Trade-Related Aspects of Government Procurement
- Exceptions: for developing countries, regional free trade areas and customs unions, and agricultural subsidies
- Dispute Resolution System with Panels and Appellate Body
- Doha Round (2001) not yet ended

- World trade volume today is roughly 45 times the level recorded in the early days of the GATT (4500% growth from 1950 to 2022).
- World trade values today have ballooned by almost 400 times from 1950 levels.
- Volume and value graphs below show trade picking up steeply since the establishment of the WTO in 1995.
- As of 2022, world trade volume and value have expanded 4% and 6% respectively on average since 1995 when the WTO was first established.
- The world's current MFN applied tariffs stand at an average of 9%.













US Current Account Balance




US Balance of Payments



US Federal Government Liabilities Finances Balance of Payment Deficit




Japan's Trade Balance



PRC Net Current Account Balances




Russian Net Balance of Payments in Current Account




