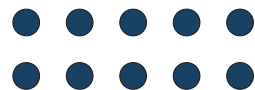

## Thomas Law

Dr Thomas Law is a Brazilian lawyer and legal scholar; a guest lecturer and adjunct professor at Pontifícia Universidade Católica de São Paulo (PUC-SP). He holds a Postdoctoral Degree from the University of São Paulo (USP) and a Ph.D. in Commercial Law from PUC-SP. Dr Law serves as President of the Brazilian Institute of Legal Sciences (IBCJ) and as President of the National Coordination for Brazil–China Relations of the Brazilian Bar Association (OAB). He is also a State Counselor of the São Paulo Bar Association (OAB-SP), contributing actively to the development of legal thought and international legal relations



## Roberta Portella

*Professor of Law*

Roberta Portella is a Professor of Law in the LL.M. and MBA programmes at Fundação Getúlio Vargas (FGV), Brazil, where she teaches International Law, and International Economic Regulation. Her academic work focuses on international trade relations, international treaties, the World Trade Organization (WTO), international economic regulation, intellectual property law, customs law, international contracts, and dispute settlement in international trade, with particular emphasis on mediation and arbitration. She holds a Master's degree in International and Comparative Law from the University of São Paulo (USP) and has extensive professional experience in cross-border legal practice. Professor Portella is a dual-qualified lawyer admitted to practise in Brazil and Portugal, specialising in the legal aspects of the international exchange of goods and services. Her professional practice includes advising domestic and international clients on inbound and outbound investment, international litigation, international contracts, trade policy, export controls, economic sanctions, and government and regulatory affairs in Brazil. Professor Portella is the founding partner of R. Portella Advogados and of the AEB Chamber for International Conflict Mediation. She also serves as an arbitrator at the Maritime Chamber of Arbitration in Brazil. In addition, she holds several institutional roles, including Vice-President for Regulatory Affairs of AfroChamber – the Brazilian–African Chamber of Commerce, Vice-President of the Foreign Trade Commission of the São Paulo Bar Association (OAB/SP), and Legal and Institutional Affairs Adviser to the Brazilian Foreign Trade Association (AEB), the country's leading organisation dedicated to international trade. She holds an LL.M. in Business Law from IBMEC, an MBA in International Trade and Business from FGV, and a Bachelor of Laws from Universidade Cândido Mendes (Rio de Janeiro). She is fluent in Portuguese and English and has been a guest speaker in Brazil and abroad, including at Fordham University and the University of California, Berkeley.

Adrian is a practising barrister, arbitrator, accredited mediator and certified public accountant. He is instructed as Counsel in a wide range of civil contentious matters, with particular focuses on arbitration, professional negligence and disciplinary matters. He sits as arbitrator – sole arbitrator, co-arbitrator or presiding arbitrator – in international commercial arbitrations conducted under various rules including those of HKIAC, CIETAC, ICC and UNCITRAL. He is named on the panels of many arbitral bodies. In addition to international commercial arbitrations, he has also participated in investor-State arbitrations and State-to-State arbitrations. Adrian is a designated national correspondent of China to the UNCITRAL, reporting on the Hong Kong SAR's implementation of the New York Convention and the UNCITRAL Model Law (as adopted in the Arbitration Ordinance). He also sits on the Advisory Committee on Promotion of Arbitration of the Department of Justice of the Hong Kong SAR. Adrian has keen academic interest in international law, which is beneficial to his handling of cases involving points of international law. In his capacity as the Deputy Secretary-General of Asian Academy of International Law, Adrian participates as an observer in the work of the UNCITRAL Working Group III on Investor-State Dispute Settlement Reform.
